#### **Investment Objective**

IXIOS Recovery, a French SICAV UCITS fund approved by AMF, is a thematic sub-fund designed for investors seeking long-term performance from the normalisation of excessive discounts on equities and bonds issued by companies in developed markets.

The objective of IXIOS Recovery is to achieve an annual performance equal to 8% (for class I) over a recommended investment period of more than 5 years.




IXIOS is an Asset Management company within the Exane Group.


